## Admission Agreement

### Withdrawal and Refund Policy

Parents/Guardians must provide 60 days' written notice of withdrawal to the Director. Tuition charges will continue until the end of the 60-day notice period. If less than 60 days' notice is provided, tuition for the following month will be required.

Tuition fees paid prior to the issuance of a dismissal letter are non-refundable for students who leave Heritage Academy. In the rare circumstance that a student must be withdrawn for disciplinary reasons, tuition fees are not refundable.

All new students begin with a 30-day trial period to ensure an appropriate fit with Heritage Academy's program. If, during this period, the school determines that a student is not a suitable candidate, a refund will be issued. The school will retain a prorated amount corresponding to the days attended during the 30-day trial.
