### Admission Agreement

Terms: Parents/Guardians are required to give 60 days notice of withdrawal, in writing, to the Director. Tuition will cease at the end of the 60 days. If insufficient notice is given, tuition will have to be paid for the following month. Tuition fees paid prior to receiving a dismissal letter will not be refunded for students leaving Heritage Academy. Should a student be expelled from Heritage, a refund will not be provided. We make all efforts to ensure a student will be a good candidate for Heritage and follow a 30 day trial period for all new students. If the student is not a suitable candidate, a refund will be provided. The school will retain a prorated amount for the 30 days of attendance.
